GLOBAL REACH

Nearly 17 million minutes or 275,000 hours were viewed on our combined broadcast
platforms—a growth of 7 percent over the prior year. Also, the number of unique viewers grew
from 40,000 people in 2020 to 65,000 in 2021, a growth of 63 percent. Viewers of Faithful
Central content live in all 50 states and also live in 55 countries, on six continents around the
world.

MINISTRY HIGHLIGHTS

- Discipleship Groups, led by Unitha Muhammad, saw monthly attendance grow by 10% to **2,700** monthly participants. **375 students**, from around the world, attended our Champion Leadership Academy in pursuit of leadership training and ministry preparation.
- Our Youth Ministries, JAM, G1 and The Source, found unique and exciting ways to keep their constituents engaged and growing in their faith. Our Rites of Passage mentorship ministry, for boys age 12 to 15, **graduated 48** in 2021.
- Over **700** Ambassador Volunteers supported the church and community, serving **39,000** hours. 2021 was truly an incredible year of service.
- The Champion Counseling Center also conducted trauma-informed training to church leaders of
 congregations throughout the city. And through the assistance of a Los Angeles County
 Department of Mental Health grant, launched the website Normalize Help.org to provide
 mental health resources to churches and the broader community.
- The community engagement team, led by Pastor George Thompson and Crystal Mozell, celebrated a banner year in 2021. Faithful Central received over \$1.4 million in grants, including one from LA County's Department of Mental Health related to increasing awareness and destigmatizing the use of mental health resources in our community.
- The finance team, led by Pastor Steve Johnson and Gail Dvorak, refinanced our campus debt with new banking partner Bank of the West, at a lower interest rate, realizing significant annual savings.

ANNUAL BUSINESS MEETING

2022—A COMPELLING STORY OF THRIVING IN OUR "NEW NORMAL".

In 2022, we remained steadfast in our mission of building champions for victorious living.

GLOBAL REACH

We introduced three new weekday broadcasts — The Wealth Cycle with Pastor George Thompson, The Download on Wednesdays with Pastor John-Paul Foster, and Living Well with Dr. Erica Holmes and Dr. Ronecia Lark. These broadcasts kept our community of believers engaged and growing in their faith.

Our in-person services, which averaged approximately **1,100** in weekly attendance. Our online campus sees just over **9,900** viewers weekly, for an average weekly attendance of **11,000**, representing a year-over-year increase of 20%.

Special moments like our "Resurrection Season"
Easter production, The Original Praise Party, Bishop
Ulmer's Single Adult Meetings and RECHARGE, a Life
Without Limits series of three events hosted by First
Lady Togetta Ulmer added bright spots to our
viewership and extended our reach beyond our
base, Southern California audience.

Nearly **20 million** minutes or **337,000 hours** were viewed on our combined broadcast platforms—a growth of 20 percent over the prior year.

Our local radio program on 102.3 KJLH, reaches thousands each week. The minutes listened to on our podcast partner— global powerhouse, PRAY.com—grew from 140,000 minutes in 2021 to over **1.2 million** minutes listened to in 2022, greatly diversifying our audience profile and reach across the globe.







MINISTRY HIGHLIGHTS

The ministries of Faithful Central are focused on supporting the ever-increasing needs that exist within our community.

Discipleship Groups, led by Unitha Muhammad, saw weekly attendance of **500** participants. In 2022, we distributed **\$100,000** in scholarships to 84 recipients to assist in their higher education. **300** students, from around the world, attended our Champion Leadership Academy in pursuit of leadership training and ministry preparation.

Our senior discipleship ministry, led by Vivian Sells, stayed connected with our seniors with weekly wellness check-ins and hosting several opportunities, designed to encourage and enrich—including, book clubs, exercise and dance classes, seminars, and their first-ever online bible study on Facebook, which kept the community together.

Our Youth Ministries, JAM, G1 and The Source, found unique and exciting ways to keep their constituents engaged and growing in their faith. JAM Children's Ministry, led by Dr. Terri McCaskill, kept parents supplied with high-energy content for their elementary school kids. G1, led by Pastor Rondell Eskridge, grew its Friday Night Service for middle schoolers, called The Mash Up, attracting over 200 kids per service, from the church and surrounding community. The Source High School Ministry, led by Pastor Matu Taylor, coordinated fun fellowship outings and developed content to help high schoolers "move forward with God".

In 2022, Pastor Matu launched "RISE" our new college age ministry, ages 18 to 24 and served over **100** through creative pop-ups, a beach day fellowship and Bible lessons. Our Rites of Passage mentorship ministry, for boys age 12 to 15, graduated **27** in 2022.

Champion Counseling Center, led by Dr. Erica Holmes, had an incredibly busy 2022. They saw **1,150** clients and collected **\$59,000** in revenue. In 2022, the Champion Counseling Center received a **\$150,000** grant from the Los Angeles County Department of Mental Health to assist in its educational efforts and raising awareness about the benefits of mental health services, particularly in under-represented communities.

In 2022, Pastor Reggie Spearman visited over **500** people who were sick and shut in. Pastor Jordan Allen ministered to over **100** families experiencing loss—each service, on average, saw 250 in live and online attendance.

Over **680** Ambassador Volunteers supported the church and community, serving **51,500** hours. 2022 was truly an incredible year of service.

COMMUNITY ENGAGEMENT

The community engagement team, led by Pastor George Thompson and Crystal Mozell, celebrated a banner year in 2022. Operation Hope partnered with seven major organizations, Shield's for Families, Department of Children & Family Service, Jenesse Center, Black Infant Health, Crystal Stairs, Westside Infant Network and the Care Portal which increased our impact and reach. We were able to provide infant formula to households in need during the critical formula shortage. We furnished over 300 households with children and four Veteran households.

Our community engagement team held a community Health Fair with the Alliance for Natural Health Foundation and Eastside Riders and gave away **32** blood pressure cuffs from The American Heart Association, over **1,000** covid-19 test kits, **5,000** KN95 masks, over **1,000** bottles of hand sanitizer, and **3,000** pairs of Bombas socks. Our "Grab at the Tab" back to school give away initiative provided over **500** packs filled with school supplies to local Pre-K to 12 grade scholars. We also partnered with 102.3 KJLH to distribute Christmas toys to over 500 children in the community.

In our Big Holiday Giveback initiative, led by RoShaun Ulmer Windham, Gina Barnes and Pamela Bell, we served **3,100** children with Boxes of Love during the Easter and Thanksgiving holiday season and provided nearly **900** gifts to children of incarcerated parents as a part of our annual Angel Tree Ministry.

In addition to our work here locally, we also donated over one million dollars in direct mission support to commitments across the globe, including: I Can Fly International, No Longer Bound Abortion Recovery Ministry, Kingdom Global Ministries; and Global Church Network, to name a few.

CAMPUS IMPROVEMENTS

Critical campus improvements were finalized in 2022. Campus Operations, led by Mia Perkins, installed an upgraded air conditioning system at the Trinity Building. Also, the restrooms on all levels of the Trinity Building were renovated in 2022.

REVENUE AND EXPENSES

Donation income of \$11,836,919 was \$1,003,782 above budget and \$298,651 less than 2021.

Total income was \$13,046,543 which is \$1,421,656 above budget and \$748,494 less than 2021.

Expenses, before depreciation, totaled \$10,398,485. The major expense categories include \$3,688,515 for Broadcast and Weekend Experiences (Ministry, Music and Media); 2,708,424 for FCBC Campus and Online (Mission and Outreach); \$4,001,546 for Finance and Operations (General, Administration, Property). Net income after depreciation was \$1,635,576, which is \$885,193 better than budget and \$750,088 less than 2021.

2022 FINANCIAL POSITION / BALANCE SHEET

What we own.

Assets: Bank accounts totaled \$3,494,193 on December 31, 2022; \$2,108,508 of which was restricted. Fixed assets (property, plant and equipment, after accumulated depreciation) were \$12,556,185. That amount includes building improvement and equipment additions during 2022 totaling \$2,030,314. Total assets of \$20,123,793 decreased by \$203,993 compared to 2021.

What we owe.

Liabilities: Accounts payable and accrued expenses for the church were \$760,734; Long-term debt includes the Bank of the West note payable and capital leases totaling \$2,474,892. (Last year this amount was \$4,516,007.) Total Liabilities of \$6,992,677 decreased by \$1,995,238 compared to 2021.

What we have if we pay off what we owe.

Fund Balances (Net Assets): The Church holds restricted funds of \$109,612 for missions and other projects. Unrestricted funds were \$13,021,504. Fund Balances decreased by \$203,993 when compared to 2021.

2023 OPERATING BUDGET

The 2023 budget anticipates revenue of \$11,444,803. Compared to the 2022 results, this is a reduction of \$1,251,084. Expenses, before depreciation, are budgeted at \$9,946,192. The budgeted net income for 2023 is proposed at \$502,177.

2023 CAPITAL BUDGET

Capital improvements of \$1,220,000 are planned.
